STARWALK AT COPPER BREAKS STATE

Quanah, Texas — First Starwalk for 2017 will begin at 8:00 PM on April 22, 2017 at Copper Breaks State Park in the Big Pond camping area.

Volunteer Terry Paridon states "the Starwalk will focus upon Native American Astronomy and its emphasis upon the lives of the first American Starwatchers. The significance of the night sky for other cultures will be discussed also." Immediately after the presentation, individuals will have an opportunity to observe through a telescope various astronomical objects, including galaxies, star clusters, and nebulae. As the night progresses, one planet, Jupiter, will be favorably situated for observing through a telescope. In order to insure that each individual has an opportunity to view astronomical objects of interest, the number of objects that will be viewed through the telescope will depend upon the number of individuals in attendance, and thus the amount of time that can be dedicated to each object.

Other Starwalk dates for 2017 are May 27, June 24, July 22, August 12, September 16, and October 21.

\$2 entrance fees apply for ages 13 and over. Some chairs are available, but visitors are encouraged to bring a chair. This event is held outdoors so visitors are encouraged to plan accordingly.
